What is the product?

Type: This Product is a common fund qualifying as an 'other fund for traditional investments' in accordance with the Swiss Federal Act on Collective Investment Schemes.

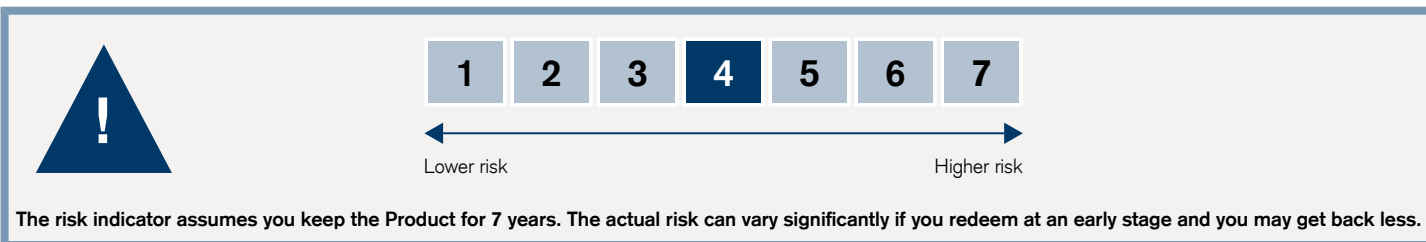
Objectives: The investment objective of this subfund is primarily to achieve suitable investment income in USD while also diversifying risk through direct and indirect global investments in a portfolio of equities and other stock certificates and uncertificated shares as well as other eligible investments. To this end, the fund management company invests at least 51% of the subfund's assets directly into stock certificates and uncertificated shares (equities, dividend-right certificates, cooperative shares, participation certificates, American depository receipts (ADRs), global depository receipts (GDRs)) in companies around the world, into derivatives (calls, puts, forwards, futures, warrants, swaps), and/or into indexes of the investments mentioned above. The fund management company can also invest up to 49% of the subfund's assets into sight and time deposits denominated in freely convertible currencies, money market instruments denominated in freely convertible currencies from issuers around the world, equities or shares in other collective investment schemes that focus on investing in stock certificates or other uncertificated shares in the financial instruments mentioned above or in the money market instruments listed above. The fund management company can also invest in structured products denominated in freely convertible currencies such as registered certificates from issuers around the world. The fund management company may also use derivatives for hedging purposes. Investments can generally be made around the world, and particularly in emerging markets.

Intended Retail Investor: This Product is intended for retail investors as well as institutional investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

Term: This Product has no maturity date. The Subfund has been established for an indefinite period of time. The Management Company is entitled to liquidate, merge, or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 4 out of 7, which is a medium risk class and poor market conditions could impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. Investors shall note that the Product may be exposed to further risks such as operational, counterparty, political, and legal risks that are not included in the Summary Risk Indicator. Cost over time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing, and incidental costs. The amounts shown here are the cumulative costs of the Product itself, for three different holding periods and in each case based on the moderate scenario set out in the performance scenarios. They include potential early exit penalties. The figures assume you invest CHF 10,000. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

Recommended holding period: 7 years

The investor can sell their investment on a daily (on business days) basis. Redemption fees will be charged at the level of the Product.
