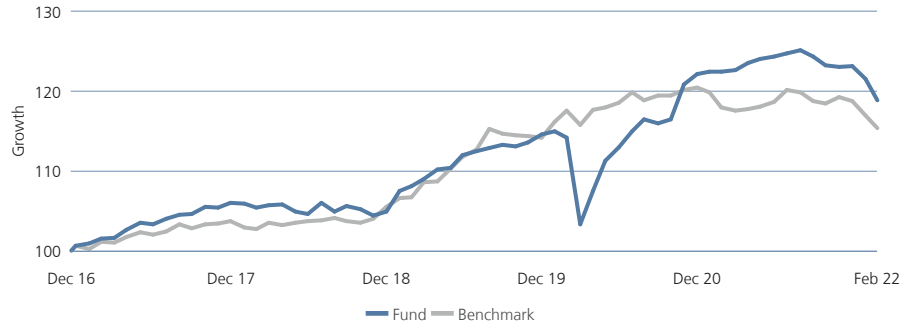

RISK CONSIDERATIONS

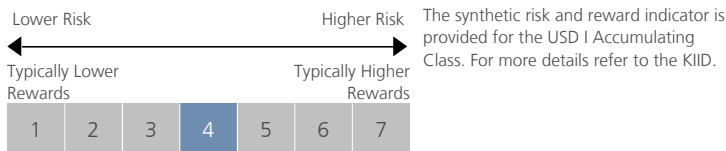
