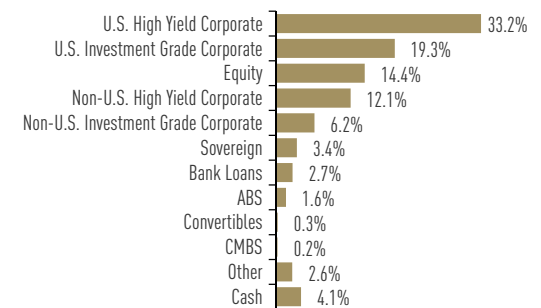
INVESTMENT OBJECTIVE

The Fund seeks to deliver high current income and long-term growth of capital by investing primarily in a variety of fixed income securities and select equity-related securities.

PORTFOLIO POSITIONING (AS OF 31/12/2016)

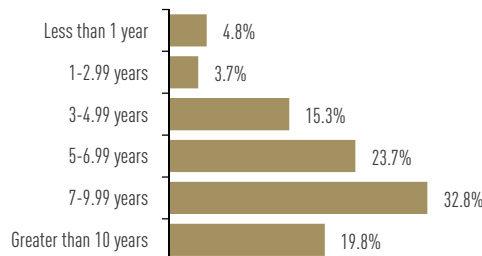
- Despite negative returns for the broader fixed income market, as represented by the Bloomberg Barclays Aggregate Bond Index, high yield credit posted positive returns during the fourth quarter of 2016, driven by rising commodity prices and the improved outlook for the U.S. economy.
- Within the credit-sensitive portion of the portfolio, we maintained our positions in the energy sector as oil prices rallied on improved global economic fundamentals and the decision made by the Organization of the Petroleum Exporting Countries to cut output.
- The portfolio continues to be defensively positioned in the healthcare sector. Hospitals have underperformed, as Affordable Care Act tailwinds have tapered off and repeal of the law was named a priority for the upcoming administration.
- Within the basic industry sector, we continue to favor metals and mining issuers. We believe select companies in this segment are poised to benefit from an improving macro environment and the potential increase in domestic infrastructure spending.
- The portfolio's allocation to **bank loans** and **high yield bonds** should help mitigate its sensitivity to rising interest rates, as these asset classes historically have demonstrated negative correlation with U.S. Treasury securities.

PORTFOLIO BREAKDOWN

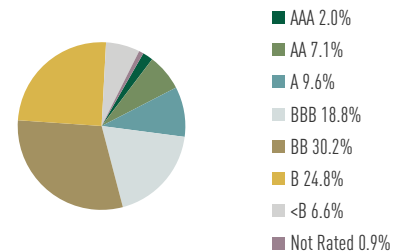

GLOSSARY OF TERMS

Effective Duration is the change in the value of a fixed-income security that will result from a 1% change in market interest rates, taking into account anticipated cash flow fluctuations from mortgage prepayments, puts, adjustable coupons, and potential call dates. Duration is expressed as a number of years, and generally, the longer a duration, the greater the interest-rate risk or reward for a portfolio's underlying bond prices. Where applicable, securities, such as common or preferred stock, convertible bonds and convertible preferred stock, ETFs, ADRs, and CPI swaps and related futures are excluded from these calculations. **Average Maturity** is the length of time until the average security in a portfolio will mature or be redeemed by its issuer in proportion to its dollar value. Indicating a portfolio's sensitivity to general market interest rate changes, a longer average maturity implies greater relative portfolio volatility. **Average Coupon** is the weighted average coupon for all the securities in a portfolio. A bond's coupon is the annual rate of interest on a bond's face value that the issuer agrees to pay the holder. Please refer to page 4 for index definitions.

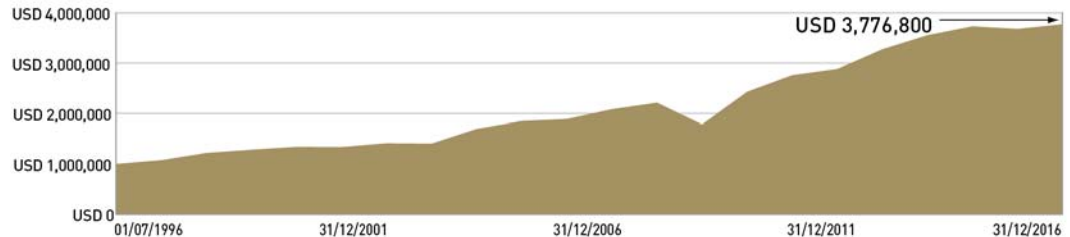

Barron's Best Mutual Fund Families rankings are based on asset weighted returns in funds in five categories: U.S. equity, world equity, mixed asset, taxable bond, and tax-exempt. Lipper calculated each fund's net total return for the year ended December 31, 2015, minus the effects of 12b-1 fees and sales charges. Each fund in the survey was given a percentile ranking with 100 the highest and 1 the lowest in its category. That ranking measured how a fund compared with its peer "universe," as tracked by Lipper, not just the funds in the survey. Individual fund scores were then multiplied by the 2015 weighting of their general classification as determined by the entire Lipper universe of funds. The process is repeated for the five- and ten-year rankings as well. Those fund scores were then totaled, creating an overall score and ranking for each fund family in each category.

Lipper Fund Award: Lord Abbett Bond Debenture Fund (Class I Share: LBNYX) awarded Best Multi-Sector Income Fund by Lipper; ranked best within the category of a total of 94 funds for the highest risk-adjusted returns for the 10-year period ended 11/30/2015. Lipper Awards are granted annually to the funds in each Lipper classification that achieve the highest score for Consistent Return, a measure of funds' historical risk-adjusted returns, measured in local currency, relative to peers.
