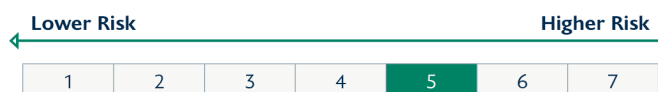

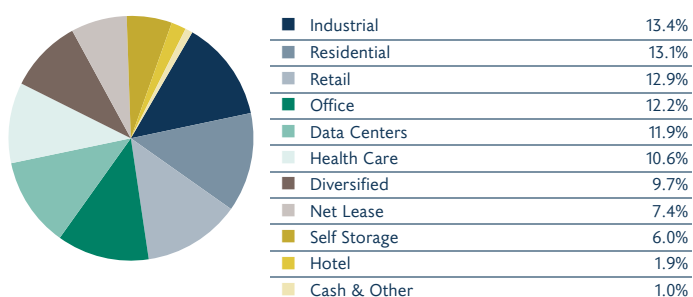

### Risk Indicator

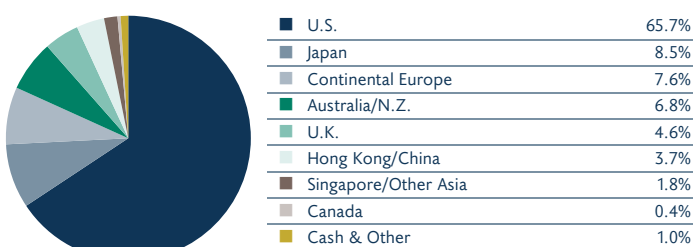
