The fund invests primarily in global dividend stocks. Its investment objective is to attain capital growth over the long term.

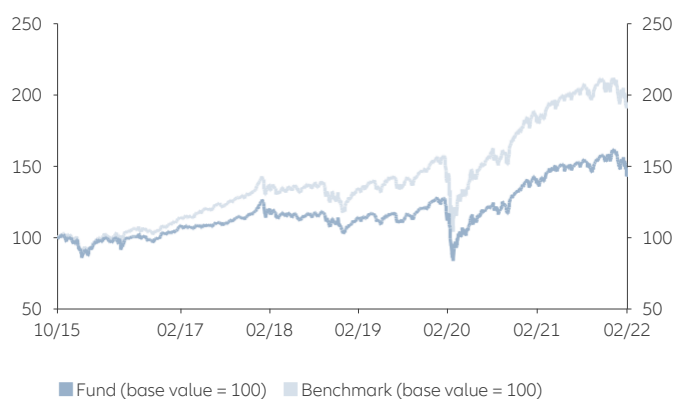

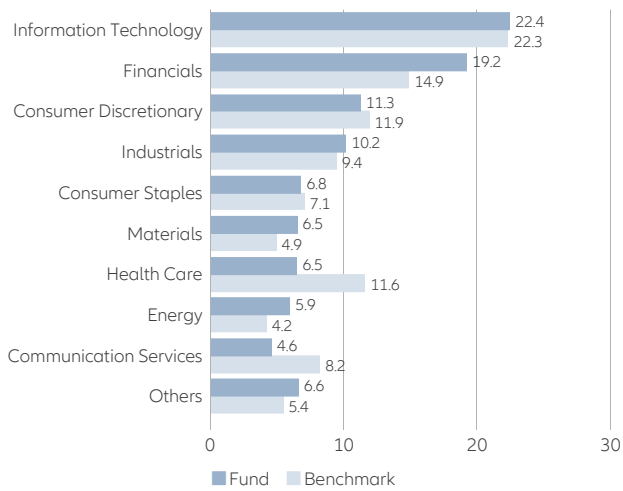

Portfolio Structure ⁶

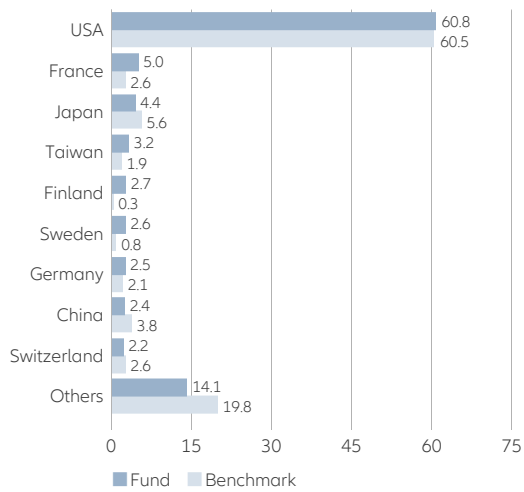
Sector Breakdown (%)
